November 7, 1859 Tuesday. A Political list of Sheriffs of Jefferson County Colorado follows for the years 1861–1974. The Kansas Territorial Legislature allowed twelve new County governments to be created 600 miles to the west in the old area known as Arapahoe County. Jefferson County was one of those 12 original. The others were Cheyenne, St. Vrain, Arapahoe, El Paso, Fountain, Park, Saratoga, North, Jackson, Steele, and Mountain. William Steele, Provisional Governor of the new Jefferson Territorial Legislature headquartered in Steel's home at Mount Vernon appointed the first twelve Sheriffs today and gave them specific duties and responsibilities to last until the next scheduled election in 1860. Walter Pollard, an original member of the Boston Company who arrived in and founded Golden City in June of this year, was named the first sheriff. Besides keeping the peace along the turbulent Vasquez Fork (now Clear Creek) mining camps, Pollard was entrusted in registering citizens to vote in the 1860 election.

December 7, 1859 Thursday

The General Assembly of the Provisional Government of Jefferson Territory adjourned this evening at 9:00 pm. They had been in session now for thirty-one days and tonight the ink was drying on the first set of established laws for this new land in far western Kansas. Effective Jan. 1, 1860 the Sheriffs of the Territory will serve all civil process, maintain a County Jail, prevent crime, arrest all law breakers, and serve as the corner. Any Sheriff will be allowed three "constables" to assist in courtroom protection and security, and as many Deputies as deemed necessary. All Deputies, including the Sheriff, would receive wages based on a fee system. Lastly, all Sheriffs will serve as executioners, or by direction of the Courts, hand out any disciplinary lashes as necessary against the backs of offenders.

January 6, 1860 Monday

One thousand people from six different communities in Jefferson County voted today for their County officials. Walter Pollard was elected to the Office of Sheriff by receiving 187 total votes. Sheriff Pollard will remain in office until the next scheduled election to be held in the Fall of this year when the ballot would contain the issue of establishing a Territorial Government.

April 4, 1860 Wednesday

Mr. R. Fulsom was arrested for suspicion of burglary by Sheriff Pollard ten days ago after Eli Carter complained of having his clothes stolen from a Toll House owned by Colorado Wagon Road Company. Fulsom was sentences to ten days of hard labor in the streets of Golden City, with a ball and chain attached to his leg. Without a proper jail (Pollard has used the Boston Company building) all prisoners were kept with a ball and chin continually fastened to their leg. Today, when Fulsom's sentence was over, Sheriff Pollard banished the offender from the Territory.

September 18, 1860 Tuesday

In his home at Mount Vernon, Governor Steele decided to hold a Fall election as outlined by the Territorial Constitution which went into effect last January. The Government was now losing its authority and credibility as the Summer of 1860 progressed. Established District Courts, for instance, were being usurped by local miner's courts, like the one established above Graham's Drugstore in Golden City last July. The next election was scheduled today for October 22, 1860.

October 22, 1860 Monday

On the ballet for today's territorial elections were three candidates for County Sheriff. Walter Pollard was making his bid to remain in office, while J>R> Gilbert and E.W. McIlhany were his opponents. There were nine precincts in Jefferson County. Henderson Ranch was the last precinct today to be counted, with Gilbert presently holding the lead of 15 votes over McIlhany , and 148 votes over the incumbent Walter pollard. When Henderson's Ranch was counted, McIlhany received 73 votes while Gilbert and Pollard received none, and gave the election to McIlhany

The people of the entire Territory also approved a measure which would cause their elected legislature to create a permanent government and hold another future election. All officials were to take office on November 11, 1860.
